(Name) \_\_\_\_\_ is a registered telecommunications service provider in the city of Orlando and has been in contact with the City of Orlando regarding the issuance of permits for certain work to be done within the City’s rights-of-way.

Under the Code of the City of Orlando, Florida, we are required to guarantee restoration of the postconstruction rights-of-way to the preconstruction condition. We hereby acknowledge that we are not required to provide a blanket construction bond to the City of Orlando to secure restoration of the postconstruction rights-of-way to the preconstruction condition (“blanket construction bond”), but instead we are voluntarily providing said blanket construction bond for our convenience, in lieu of providing individual construction bonds per project or permit.

In consideration of the City’s acceptance of a blanket bond construction bond for restoration of the postconstruction rights-of-way to the preconstruction condition,  
(Name) \_\_\_\_\_ agrees to hold harmless and indemnify the City of Orlando, its agents, and employees, and elected and appointed officials, from and against all claims, damages, losses, expenses, suits, actions, or possible liability, whether in law or in equity, including costs and attorney’s fees (and costs and attorney’s fees on appeal) resulting in any way from the issuance of a blanket construction bond to (Name) or the City’s acceptance of same or the City’s decision to allow \_\_\_\_\_ to use a blanket construction bond to satisfy its bond requirements under City Code.

As a part of the above agreement, we acknowledge that it is the responsibility of the applicant, (Name) \_\_\_\_\_ to complete all restoration of the City’s rights-of-ways disturbed by us or on our behalf, to comply with Chapter 23 of the City of Orlando Code of Ordinances, and to provide any additional information or documentation required. We further understand and agree that the blanket construction bond will not be released until eighteen (18) months after the final permit obtained by (Name) using the blanket construction bond is finalized. We understand this fact and agree to the City harmless as outlined above. We acknowledge that the City has relied on our representations made in this Agreement and would not have agreed to allow us to use a blanket construction bond except for our execution of this Agreement.
